Call to Order/Roll Call

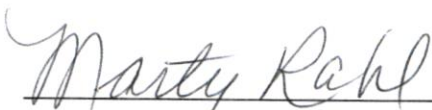

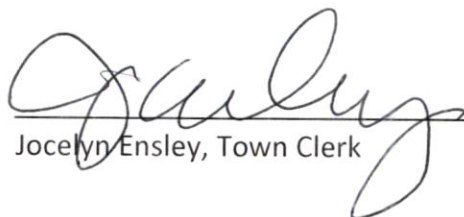
Regular Meeting

The Board read an email from Richard Hopp, ORC, detailing the requirements by CDPHE for tank inspections, cleaning, and maintenance work that must be performed before the end of 2026. The Board read and reviewed a quote from Marine Diving Solutions to perform leak detection/inspections on tank #1, tank inspection and cleaning on tank #2, and tank inspection and cleaning on tank #3. Jocelyn Ensley stated that Greg Colter with Colorado Rural Water heavily recommended having Marine Diving Solutions camera the line from the water plant to the water tank and asked the Board to review their hourly quote included in the documents provided to them. Greg Colter stated that he believes that the line from the water plant to the tank could have blockage and/or a break in the line and could be a part of why the tanks are not equalizing properly and could be the source of ground water infiltrating tank #1. The Board discussed the quote from Marine Diving Solutions for inspections and cleaning as well as the hourly quote for camera services. Geoff Pagnotta made a motion to approve the quote from Marine Diving Services to inspect tank #1 for leak detection and inspect and clean tank #2 and #3. Aimee Kramer seconded the motion. The motion passed unanimously. Aimee Kramer made a motion to approve the quote from Marine Diving Solutions for hourly camera service work from the water treatment plant to the tanks, capping their services at \$1200.00. Kathy MacCormack seconded the motion. The motion passed unanimously.

At 6:40 p.m., Kathy MacCormack made a motion to close the Emergency Meeting. Sandra Steele seconded the motion. The motion passed unanimously.
