**Call to Order/Roll Call**

Mayor-Protem, Sheila Henderson, called the Emergency Board Meeting to order at 9:00 a.m. at the Town Hall at 2067 Main Street in Rye, Colorado. Those in attendance were as follows: Sheila Henderson, Mayor Protem; Sandra Steele, Trustee; Markus Buck, Trustee; Kathy Dufty, Trustee; Ariel McKinley; Aimee Kramer, Resident and Heidi Miller, Resident. Those absent were: Marty Rahl, Mayor and Patrick Ryan, Trustee.

**Regular Meeting**

The Board met with a candidate for an interview to fulfill the Emergency Temporary Clerk position, in the case it is needed, while Jocelyn Mower is on maternity leave.

The Board met with candidates who had submitted letters of interest to fill the 1 (one) vacant board of trustee's position and interviewed them individually.


Sandra Steele made a motion to accept Ariel McKinley for the Emergency Temporary Clerk position with training to begin in December 2022 with Jocelyn Mower for the following duties: Monthly Water/Sewer Billing, preparing Board Packets, and Bank Deposits. Ariel McKinley will work as an independent contractor and will be paid for all training and any work performed thereafter, in the event she is needed, and in the amount agreed upon by the Board of trustees. An offer letter with the agreed upon terms will be sent to Ariel McKinley from the Board for her to accept and sign. Markus Buck seconded the motion. The motion passed unanimously.

The Board discussed the three candidates who had interviewed for the vacant board of trustee's position. Due to the Board being unable to come to a majority decision on who to appoint for the vacant board of trustee's position, they will vote to appoint a candidate at the next regular monthly meeting on Wednesday, October 12, 2022.
